Pursuant to the Resolution adopted unanimously in the Executive Committee Meeting of East Bengal Club ("the Club") held on 4th September, 2020 in the Club tent, Notice is hereby given that Extra Ordinary General Meeting of the members of the Club ("Members") will be held on Tuesday, the September 29th, 2020 at 3:30 PM at the Club tent, Kolkata- 700 021 in terms of Club Rule 35(a), complying with the Government Guidelines in respect of COVID-19, to consider the following agenda: -

1. To approve the Term Sheet signed with Shree Cement Limited, ratify the decision of Executive Committee of the Club and other matters related thereto

The Members are hereby apprised that the Club has executed an agreement on 1st September 2020 ("Term Sheet") with M/s. Shree Cement Limited ("SCL") for collaboration in the form of joint venture by formation of a new company ("New Entity") with SCL (together with its affiliates) in relation to football and all other sporting related activities carried out by the Club ("Collaboration").

The Members are further apprised that as per Term Sheet, all sporting activities (football or otherwise) carried out by the Club and also all the assets and properties (including intellectual property rights) of the Club are required to be transferred (with or without adequate consideration as the context requires) to the New Entity (a company licensed under Section 8 of the Companies Act, 2013) formed for the purpose of Collaboration. The copy of the Term Sheet executed as part of Collaboration is available for inspection by the Members. The Club and SCL are currently discussing and negotiating final definitive documents for the purpose of Collaboration.

All the actions and decisions, as above, have been taken by Executive Committee of the Club in its meeting dated 19th August 2020. The Members of the Club may kindly consider and approve the Term Sheet signed with SCL, ratify the decision of the Executive Committee taken in its meeting dated 19th August 2020 and approve other matters in relation thereto by passing the following resolution(s): -

"RESOLVED THAT the unanimous approval of the Members of the Club be and is hereby accorded in relation:

- 1) to approval of Term Sheet (Agreement) executed on 1st September 2020 by and between East Bengal Club (Club) and Shree Cement Limited (SCL) for collaboration in the form of joint venture by formation of a new company ("New Entity") in relation to football and all other sport related activities carried out by the Club and to transfer all the assets and properties (including intellectual property rights) of the Club to the New Entity as per terms agreed in the Term Sheet executed by the Club and SCL;
- 2) to ratification the decision of Executive Committee taken in its meeting dated 19th August 2020 for execution of the Term Sheet with SCL for the purpose of Collaboration;

- 3) to authorizing the Executive Committee for entering into the definitive agreement(s) or such other binding agreements as may be necessary for the purpose of above Collaboration and to do all such things, acts, deeds as may be necessary and to sign, execute, deliver, enter into all documents, papers, agreements, contracts as are required for the above purpose including nominating one or more members of the Club for holding the shares of the New Entity on behalf of the Club and to nominate upto two members of the Club to hold the position of director in the New Entity formed for the purpose of Collaboration;
- 4) to transfer license / code / registration of Club held and/ or applied for by the Club itself or East Bengal Club Pvt. Ltd. (an affiliate of the Club) issued by All India Football Federation and Asian Football Confederation for participation in any league or tournament including Indian Super League to the New Entity; and
- 5) to approve that in case of differences / conflict between Club Rules (as amended from time to time) and Term Sheet / Definitive Agreement(s) entered into between Club and SCL (together with its affiliates), the conditions of the Term Sheet/ Definitive Agreement(s) will prevail."

2. To consider and approve amendments in Rules of the Club required for facilitating the Collaboration as mentioned in Agenda item no. 1 above with SCL

The Members are informed that certain rules of the Club ("Club Rules") [Rule 3, 12 (c), 12(d), 13, 17 x) (k), 18, 19(b), 29A and 35] are required to be amended so as to give effect to the terms and conditions agreed under the Term Sheet signed on 1st September 2020 and definitive documents to be executed after due negotiations. The Members are requested to consider the following, approve the amendments as proposed and pass the resolution unanimously as under:

The Members are informed that the Club has 100 percent controlling stake in East Bengal Club Pvt. Ltd. (a company incorporated by the Club) ("EBCPL") by way of control / holding entire equity share capital, securities and other controlling rights of the EBCPL through its nominees. As part of the Collaboration with SCL, the 100 percent controlling stake of EBCPL may also need to be transferred to the New Entity to be formed pursuant to Collaboration with SCL.

The Members, therefore, are requested to consider and approve transfer of the 100 percent controlling stake in EBCPL held by the Club (by itself or through its nominees) to the New Entity by passing the following resolutions:

"RESOLVED THAT the unanimous approval of the Members of the Club be and is hereby accorded for transfer of 100 percent controlling stake in East Bengal Club Pvt. Ltd. (a company incorporated by the Club) ("EBCPL") held by Club through its nominees in favor of the New Entity to be formed pursuant to Collaboration with SCL, with or without consideration, as may be agreed.

"**RESOLVED THAT** the Executive Committee of the Club be and is hereby authorized to do all such acts, deeds, things and take actions as may be required including signing of any paper, document, letter, agreement, transfer deed or forms for this purpose.

4. To take up any other additional agenda item / matter as may be placed before the Members during the meeting or before, with request for waiver of requirement of 14 days' notice.
